Measures for the Recommended List of Enterprises in the Country Market for Foreign Contracted Projects (for Trial Implementation)

Chapter One Purpose and Purpose

Article 1 In order to meet the requirements of the development situation of the foreign contracted project business, maintain the order of the country's market operations, strengthen the in-process supervision and post-assessment of foreign contracted engineering projects, and encourage and support the implementation projects with good performance and good credit to expand their business, according to the "The Regulations on the Administration of Foreign Contracted Projects and other laws and regulations, as well as the relevant regulations of the foreign contracted engineering industry, formulate this system.

Article 2 The purpose of these Measures is to put forward a list of recommended companies in the country's market based on the database of industry enterprises' overseas implementation projects through comprehensive evaluation of the implementation of projects by enterprises in the country's market, and publish it within a certain range, so as to promote relevant countries. Market business developed in an orderly and healthy manner.

Article 3 The country market that implements the enterprise recommendation list system is mainly based on the implementation and participation of Chinese-funded enterprises in overseas projects in the past three years, market characteristics, development potential, and business risks. Determined after research by the Market Committee.

Chapter II Conditions for inclusion in the recommended list

Article 4 Enterprises included in the recommended list must meet the following conditions:

(1) In the past three years of business activities, strictly abide by relevant policies, laws and regulations, and business ethics, have no violations, violations of discipline, commercial bribery and other bad behaviors, and have no bad records in government departments, financial institutions, industry organizations, etc.;

(2) In the past three years of business activities, honesty and trustworthiness, management standards, actively fulfilling social responsibilities, focusing on project sustainability and localized operation, the contracted project has no major construction period, quality, management problems, and safety accidents, and no incidents have occurred. Significant loss;

(3) Actively safeguard national interests, industry interests and image, abide by relevant industry regulations, and obey the business coordination of contractor associations and business (participation) offices of embassies abroad;

(4) There are projects under construction or completion (including general contracting and subcontracting) with a contract value of not less than 10 million U.S. dollars in the country's market, and relevant filing procedures shall be handled in accordance with relevant regulations;

(5) The performance of the enterprise in the country's market is good, and the local owners, communities and government agencies, the business (participating) offices of embassies abroad and the Chinese-funded enterprise associations have evaluated them well.

Article 5 The companies included in the recommended list must be member companies of the contractor association and actively perform their membership obligations, including but not limited to filing project status with the chamber of commerce in accordance with regulations.

Chapter III Working Procedures

Article 6 The recommended list of enterprises in the country market shall be dynamically adjusted by the survival of the fittest. The overall reconsideration and

adjustment will be made at the beginning of each year, and it will be determined after deliberation by the chairman of the contractor' s meeting.

Article 7 Enterprises that intend to apply to be included in the recommended list may submit a written application to the contractor's association and submit relevant certification materials, including:

(1) Application letter. Including the company's brief introduction and contact information, the country to be included in the recommended list and the main reasons (name and content of the contracted project in the country, amount and source of funds, name of the owner, progress, etc.), and the promise of the provided materials Authenticity and bear the legal responsibility arising therefrom.

(2) Relevant performance certification materials.

Article 8 After accepting the application, the contractor will verify the relevant information, preliminarily examine whether it meets the requirements for inclusion in the recommended list, and provide feedback to the applicant enterprise.

Article 9 After determining the country market for the recommended list system at the beginning of each year, the contractor will propose a preliminary country market based on the enterprise application, business statistics, filing information, industry credit history, project supervision and post evaluation, etc. List of recommended companies.

Article 10 If an enterprise disagrees with the preliminary recommended list, it may file an appeal or application to the Coordination Committee of the Contractors Association, and the Coordination Committee will review it.

Article 11 The contractor will further solicit opinions from the president units, domestic government authorities, the economic and commercial (participation) offices of the embassies abroad, and relevant financial institutions on the preliminary list of recommended enterprises, and on this basis, submit it to the coordination com for review .

Article 12 The recommended list of companies reviewed and approved by the Coordination Committee will be submitted to the Chairman' s Meeting of the Contractor' s Association for deliberation and determination.

Article 13 The contractor will, according to the needs of the work, report to relevant domestic government departments, financial institutions, economic and commercial (participation) offices of embassies abroad, and foreign embassies (consulates) in China, project owners, international multilateral development financial institutions, International organizations and other relevant institutions publish the recommended list of companies in various countries and markets in Chinese and English.

Article 14 If an enterprise that has been included in the recommended list is punished for acts of unfair competition or no longer meets the conditions for inclusion in the recommended list, it will be adjusted in accordance with the working procedures.

Article 15 For companies that have not been included in the recommended list, the contractor will establish a guidance mechanism to assist the company to familiarize itself with the overseas market, encourage and support the company to cooperate with the listed companies through subcontracting, joint ventures, etc., and gradually improve the performance of the company. And strength, when the conditions and requirements are met, an application can be submitted to the contractor.

Article 16 For companies not on the recommended list to track and promote highly professional projects, the contractor may make special recommendations based on the company's professional strength and performance, and on the basis of compliance with the relevant coordinated recommendation principles, without being restricted by the list.

Chapter 4 Application of Recommendation List

Article 17 When carrying out relevant project coordination, recommending enterprises to participate in intergovernmental cooperation projects or projects using Chinese funds, the contractor will follow the relevant coordination regulations of the Chamber of Commerce and will refer to this system and give priority to supporting the recommended list. enterprise.

Article 18 The contractor's association may, at the request of the enterprise, issue a letter of support and credit certification required by financial institutions, project owners and related parties based on the recommended list. For related requirements, please refer to the "Interim Measures for Handling Member Enterprise Credit Certificates and Recommendation Letters."

Article 19 For member companies that are not included in the market recommendation list, follow up and promote projects. If the company has the corresponding strength and performance, meets the grading standards and relevant coordination and recommendation principles, the contractor's association may make special recommendations to the owner at the request of the company.

Chapter V Supplementary Provisions

Article 20 These measures are formulated and interpreted by the Industry Rules Committee of the Contractors Association.

Article 21 These Measures shall be implemented after being adopted by the Third Council of the Seventh Session of the Contractors Association on November 30, 2017. The "Regulations on the Coordination of the Total Market Volume of Foreign Contracted Projects (for Trial Implementation)" and the "Detailed Rules for the

Coordination of the Market of Specific Overseas Contracted Projects (for Trial Implementation)" shall be repealed from the date of implementation of this system.
